

**Call for Proposals**  
**for**  
**Fellowship of Nurse Researchers Society for Innovations**  
**(FNRS 2024-2025)**

The NRSI (Nurse Researchers Society for Innovations) invites applications for FNRS 2024. The duration for the fellowship will be for one year. Interested researchers are to apply through electronic mail to [nrsiindia@gmail.com](mailto:nrsiindia@gmail.com)

Last date for application: 15<sup>th</sup> June 2024

**Eligibility criteria:**

- 1 The applicant should be a life member of NRSI.
- 2 Should hold a Ph.D. degree in nursing.
- 3 Should have at least 2 published original research works in peer-reviewed journals.
- 4 At the time of application, the applicant should be 50 years or below of age.
- 5 The candidate will submit along with their applications the CV of the research mentor which should clearly indicate the research work done by the Mentor in the last 5 years. NRSI reserves the right to advice the candidate to choose a new mentor if required.
- 6 It is mandatory that the proposed mentor should be a NRSI member, and have minimum 2 published original studies in peer reviewed journals as 1<sup>st</sup> author. Any individual who has been a mentor in the previous year will not be eligible to be a mentor in the subsequent year.
- 7 The proposed research study should have clearance of the Institutional review board of the respective research settings. If the IRB certificate is not available at the time of application, the applicant should provide IRB certificate within the first 3 months of starting the fellowship. Failure to

provide IRB certificate within the stipulated time will result in termination of the fellowship.

- 8 The metrics on which the candidates will be judged include (but not restricted to) a strong research proposal, and publications record. Due weightage will be given to publication in reputed journals.

### **Fellowship Amount and disbursement**

The FNRS fellow will receive a grant of up to Rs 50,000 as funding. The grant of money will be released in installments at various quarters of the year of fellowship. (please check the conditions that apply for release of instalments). NRSI will credit the grant amount in instalments to the bank account of the institution where the Researcher is conducting the study.

The fellow is responsible for submission of utilization certificate of the grant within one month of completion of the final work along with Bills and Vouchers of expenses incurred during the period. The utilization certificate should be duly audited and signed by the Chartered Accountant with the sign and seal of FNRS fellow, Mentor and head of the institution where the research was conducted. Utilization Certificate for each financial year ending 31st March has to be enclosed, along with request for carry forward permission to next year.

### **Procedure for application and fellowship**

1. The fees for application is a non-refundable amount of Rs.2000/-. The applicant is responsible to get the proposal reviewed and scrutinized by the mentor before submitting for FNRS grant.
2. In the first phase of scrutiny, an external committee appointed by NRSI will evaluate the proposal for its merit.
3. If the proposal passes the 1<sup>st</sup> phase, the applicant will present the proposal with the help of a power point at a scheduled date and time through an online platform in front of a NRSI appointed committee.

4. The decision for award of FNRS will be communicated through emails to all applicants.
5. The period of one year will be counted from date of acceptance of the proposal as intimated to the selected fellows.
6. The research fellow has to submit progress reports to NRSI on the 3<sup>rd</sup>, 6<sup>th</sup>, and 9<sup>th</sup> months of starting FNRS in a prescribed format.
7. Grant instalments will only be released after the internal assessment committee is satisfied with the progress report.
8. The final report of the research work should be submitted at the end of one year of fellowship.
9. In case a fellow decides to leave the program midway he/she will have to pay back the drawn amount to NRSI
10. Upon satisfactory evaluation of the final report, the fellow has to submit a manuscript related to the research study to the Journal of Nurse Researcher Society for Innovation (JNRSI) for publication.
11. The fellow has to present the results of the study in the NRSI national conference where he/she will be presented with the certificate of award and the last installment of the FNRS fellowship will be released thereafter.
12. The FNRS recipient need to acknowledge NRSI support in any presentation and publications that emanate from the proposed research project.
13. NRSI shall be the owner of all the intellectual property (patentable/non-patentable) generated by the research study. However, there shall be a royalty sharing agreement between NRSI and the fellow inventors, as and when required.
14. Any deviation from the procedure and timeline on the part of the candidate has to be informed to NRSI through email.

- 9 No objection certificate from the employer.
- 10 Institution Review committee certificate for ethical clearance (if already obtained)
- 11 Receipt of NEFT transaction paid as application fees.
